



COLLABORATION PROPOSAL BETWEEN (.....) AND THE DESIGN FOR ALL FOUNDATION

PREAMBLE

Given the market globalisation, the demographic ageing of population in developed countries, the constant evolution of new information technologies and a greater respect to the diverse characteristics and needs of users and consumers; Design for All has been introduced into our society in such a way, that policies that arise at European level already incorporate it with the aim of promoting diversity as a starting point when designing a product, a service or an environment.

Since Design for All means the Design and Improvement of the environment, with the aim that everybody, including future generations, regardless of age, gender, capabilities or cultural background, can participate on an equal basis in social, economic, cultural, leisure and entertainment activities, as well as accessing, using and understanding whatever part of the environment with as much independence as possible.

And mutually recognising the respective qualities in which they act and the full legal capacity to contract and to commit themselves and in previous agreement.

DECLARE

That it is the will of (.....)(..... *from now onwards*) to collaborate in promoting and disseminating Design for All.

Design for All Foundation is a private non-profit foundation, subject to the current legislation of foundations enforced by the Generalitat de Catalunya, and with autonomous, state and international scope of performance, having as its main purpose to develop, promote, research and disseminate the concept of Design for All to all companies and organisations, private as well as public, administrations, educational agents, and among designers and the professionals in general that are involved in modifying the environment, products and services.

The Design for All Foundation also aims to propose companies, organisations and administrations to integrate the values that are promoted by Design for All in their quality processes.

And for the record, it is the will of both parties to establish methods of collaboration to jointly organise interventions regarding Design for All.



Consequently, the parties agree to adhere to the following present Agreement:

CLAUSES

FIRST. - It is the will of the representatives of the two organisations to carry out various acts of promotion and dissemination regarding Design for All which will be set out in accordance to a programme mutually agreed on.

SECOND.- It is the will of (.....) to give support to the initiative “Commitment to Design for All” of Design for All Foundation with the aim that companies assume the commitment to adapt progressively its services, products, projects and organisation systems to the capabilities, needs and expectations of all its employees, consumers and users, by means of the Design for All principles.

THIRD.- The Design for All Foundation is committed to keeping the organisation informed of all the actions and activities carried out regarding Design for All, as well as disseminating the actions conducted by (.....) on the Foundation web site and among the national and international organisations that support Design for All.

FOURTH.- The Design for All Foundation will prioritise the participation and collaboration of (.....) in all those activities carried out by the Foundation in the future.

FIFTH.- The Design for All Foundation will inform the organisation on possible subsidies or grants and programmes that could facilitate the dissemination and implementation of Design for All.

SIXTH.- This agreement will come into effect from the date of its signature and it will be automatically extended annually, unless one of the parties notifies the other in writing about its will to terminate the collaboration, always giving a minimum of three months notice.



SEVENTH.- This agreement is only rescindable by the mutual agreement of both parties.

And as proof of agreement, both parties sign and ratify in duplicate the agreement, in the place and dates indicated above.
